

On Monday, September 19th we will be holding a Dedication Ceremony of our beautifully renovated and expanded Center. Please mark the date on your calendar and join us for this celebration.

In addition to the physical changes that have occurred at 29-01 Berkshire Road, there has also been a change in the Center's leadership. After five years as the Center's Executive Director & Principal, Carolann Garafola has accepted a position with Cerebral Palsy of North Jersey. While her enthusiasm and dedication will be greatly missed, we wish her the best in her new ventures.

The Center has established a Search Committee to find a new Executive Director & Principal that will lead the Center as we continue our pursuit of providing the utmost in therapeutic and educational programs for our special children. Rest assured, during this important quest to find the ideal candidate, the Center is under excellent interim direction. Assuming the role as Interim Executive Director is a familiar face at the Center, Lynn Barral. Lynn has been with the Center for eleven years. She began her tenure as a physical therapist, and six years ago became the Center's first Assistant Director. Dr. William Cobb is serving as the Center's Interim Principal. No stranger to the Center, in the summer of 1997, Dr. Cobb assisted then Executive Director, Mary Ann Aman in obtaining state approval for the creation of the preschool classes. Subsequently, Dr. Cobb served as the Center's first Principal for three years. Between Lynn's extensive experience and familiarity with the Center and its children, and Dr. Cobb's remarkable career as a Principal, the Center's transitional leadership is well-established.

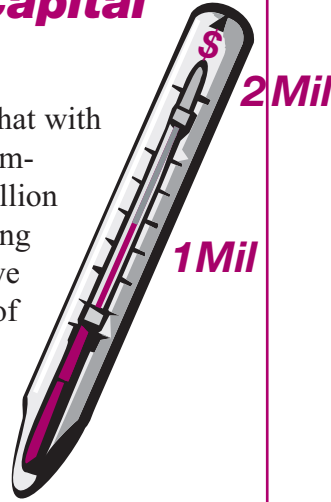
